A RESOLUTION BY THE MAYOR AND CITY COUNCIL OF THE CITY OF PAYETTE, PAYETTE COUNTY, IDAHO, AUTHORIZING THOSE INDIVIDUALS SITTING ON THE ADMINISTRATION/FINANCE COMMITTEE AND EMPLOYEES OF THE CITY CLERK'S OFFICE TO BE SIGNATORIES ON THE BANK ACCOUNTS OF THE CITY IN ORDER TO CONDUCT THE FINANCIAL BUSINESS OF THE CITY OF PAYETTE.

WHEREAS, the City of Payette has made new committee assignments; and

WHEREAS, the financial business of the City of Payette shall continue on an uninterrupted basis,

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF PAYETTE:



These officials and employees are authorized to deposit all or any portion of the moneys and funds of the City of Payette in its name with First Security Bank of Idaho or U.S. Bank of Idaho at banking offices in one or more commercial or checking accounts, one or more savings accounts or both and/or in other classes or forms of accounts including certificates of deposit, repurchase agreements, money market accounts, all on such terms as the person making the deposit may agree with the Bank.


