I. APPROVAL OF MINUTES

A. 08-22-2013 Regular Meeting Minutes

A motion was made by Ladley and seconded by Hanigan to approve the regular meeting minutes 08-22-2013 as written.

After a unanimous voice vote by the Commission, the motion CARRIED.

II. COMMUNICATIONS – None heard

III. PUBLIC HEARINGS

- A. An application by Frank & Kimmie Serrano for a Conditional Use Permit to build a 36'x40' pole barn style shop with a roof height not to exceed 25' at 2067 Shelley Dr, Lot 13 in Blk 2 of Vistair Replat. The property is zoned A-Residential.

Kimmie Serrano – 2067 Shelley Drive; Payette, Idaho

Mrs. Serrano stated that she wants to build the shop and stub in electrical. Right now they are just trying to get stuff covered up before winter. Dave Jeffries will be doing any of the work. Commissioner Franklin asked if plumbing will be in the shop. Mrs. Serrano stated that they will stub it in, but will not be sure when they will be installing a bathroom. Commissioner Franklin asked if it met all the setback requirements. Mrs. Serrano stated yes. Commissioner Franklin stated that all the property pins will need to be exposed. Mrs. Serrano stated they have exposed most of them.

- B. An application by Wilson-Pruett Tire Factory for a zoning change at 517 So 9th St, A Ptn of Lots 9 and 10 in Block 1 of Fairview Addition from B-Residential to C-Commercial.

Joe Wilson – 517 So 9th St; Payette, Idaho

Clerk Cordova stated that when the storages went in they wanted to re-zone at that time and this property owner was asked and he said no. When the new owner took over the business he was unaware of the issue. This is something the city has instigated and at the time he came in we did not want to hold him up.

- C. An application by Tiffany Jackson for a Conditional Use Permit to allow for 24 hour a day / 7 days a week group childcare at 1005 Center Ave, Gorrie Addition, Lots 1 & 2, Block 16. The property is zoned B-Residential.

Tiffany Jackson – 1005 Center Avenue; Payette, Idaho

Mrs. Jackson stated that she does not want to do 24/7 but wants to do night daycare or weekend daycare. She stated that she wants to do evening daycare. Commissioner Youngberg asked how many kids she currently has. Mrs. Jackson stated that she currently has 6 children, but can have up to 12 children.

No one else addressed the Commission.

Public Hearing closed at 6:13 p.m.

VI. NEW BUSINESS

A. Frank & Kimmie Serrano – 2067 Shelley Drive - CUP

A motion was made by Franklin and seconded by Henderson to approve the conditional use permit to build a 36'x40' pole barn style shop with a roof height not to exceed 25' at 2067 Shelley Drive and no residential use.

After a unanimous voice vote by the Commission, the motion CARRIED.

B. Wilson – Pruett Tire Factory – 517 South 9th Street - CUP

A motion was made by Youngberg and seconded by Henderson to send a favorable recommendation to the Council to re-zone the property from B-Residential to C-Commercial.

C. Tiffany Jackson – 1005 Center Ave – CUP

A motion was made by Hanigan and seconded by Youngberg to approve the conditional use permit to allow for a 24/7 day a week daycare, no more than 12 children, can be revisited upon complaints and must comply with all city, state and federal regulations and laws.

After a unanimous voice vote by the Commission, the motion CARRIED.

VII. PUBLIC COMMENT –

Clerk Cordova stated that in the Independent Enterprise they stated that the Payette Primary School hosted the 3rd Annual Play Day. That is actually inaccurate. This is put on by the City of Payette and organized by Tiffany Howell and Jennifer Kelley. She would like to give a huge thanks to all the departments, staff and community members that helped in putting it together.

Clerk Cordova stated that Jake Sherer passed away and he used to take care of city property across from his home on North 20th St. Mr. & Mrs. Sherer watered, mowed and took very good care of the park. The Class of 51' did put up a sign naming it the "Jake Sherer Park". Commissioner Hanigan asked who will be maintaining now. Clerk Cordova stated that the city will be taking care of it.

Clerk Cordova stated that we will probably have a final plat subdivision for you to review at the next meeting.

The services provided under Article D of this Amendment are expected to be completed within 30 days of the date of this Amendment.



My present plans are to move to Payette in the early spring of 2014 and I'm sending this container full of aircraft and parts to store until I complete my move.




