WORK SESSION

- A. Special Events Permit Procedure: Mayor said we have talked about special events permits before and he asked if everyone has had a chance to look at the application and procedure. Dale stated what we were talking about before was possibly streamlining. Ms. Cordova stated we wanted some direction for the committees on what the Council would like to see. The Council discussed the Nazarene Church and it is on private property. Jensen stated schools could be exempt under current code. Heleker asked if we have been non-compliant when holding functions that don't involve the district. Mayor stated this is when public safety needs to know what events are happening. Jensen has a concern when on private property, is there a way to handle this on private property. Chief Clark stated he understands it is both private/public, he has a responsibility to protect the public. He talked about biker club coming in and he would want to know about this. Dale asked what the chances are of that happening. We have ordinances in place for noise. Chief Clark stated it gives him something to look at and check it out. Dale asked why the law abiding people should have to go through this. Chief Clark stated there are a lot of reasons why we need this. Mayor gave analogy of law abiding people license their vehicle. Jensen has problem with the statement of on private property for a family event. Wickersham stated he doesn't have a problem of the Nazarene Church getting special event permit, just has a problem with them paying a fee. Understands both sides. Dale asked if possible if something can be submitted to police department to notify them. If public property and there will be street closure and needs porta potties then they need a permit. Chief doesn't want overflow and not know about it, he is protecting the public either on public or private property. Dale stated she is trying to find what will work best for the citizens versus the city. Mayor suggested Mr. Osborn might need to get involved. Jensen stated a fee should only be charged on public property. Ms. Cordova talked about the circus on private property that did affect our public safety. Jensen asked if we could do through departments and if denied, then they could appeal to City Council. Staff will review and can bring back suggested changes to Council, doesn't need to go to committees.

- A. EMS Medical Supervision Plan & Independent Contractor Agreement: Mayor stated this is a bi-annual update.

A motion was made by Heleker to approve the EMS Medical Supervision Plan & Independent Contractor Agreement as presented. The motion was seconded Nelson.

Dale asked Chief Castenada, on page 20 under training, #3, why are we giving feedback to Bonner County EMS. Stated was a typo. Also on page 24, patient care and documentation #4, strike one of the "must". On #3 cases deemed by any fire department providers, on page 28 under compensation, to bring to light Dr. Morris Smith. He is a wonderful man and doesn't charge for this service.

- B. Agenda Request – Karen Lockwood – Dog Park:

Karen Lockwood, 2553 Runway Court, Payette, addressed the Council. She is a resident of Payette and would to propose changes to the dog park behind the armory. She proposed that it be fenced and provide an ADA accessible park for area residents and their dogs. It would be a wonderful place to socialize for both dogs and owners. This would be the first of its kinds in the area. She has made calls for estimates, but hasn't received calls back. Ms. Lockwood distributed a drawing of proposed fencing for small and large dogs. There is water available at site. She also proposed benches, signage and more shade trees. Could do fundraisers to get accomplished. Nelson asked if we owned park, was stated we only maintain park, the armory owns park. Mayor will make contact and find out their intent. Dale stated she is aware of a couple of individuals that are working on a park right now and provided her with information.

- C. Agenda Request – Christmas Events by Chamber of Commerce:

Kathy Patrick, 1095 N. 6th Street, addressed the Council. They would like to do a Christmas celebration on December 4th. They would like to have Santa ride on a fire truck and then Santa will go to museum. Christmas light on tree in Bancroft Park would be lit that night. They would like to have a Christmas decorating event for business's and citizens and have cash awards. Mayor asked if this is a separate event from the downtown businesses and their punch cards. Ms. Patrick stated this will only benefit all the community. Ms. Cordova stated we have a special events permit that has been submitted for the Downtown business group. The Council asked if they can work with this group and Ms. Patrick stated the other group has chosen not to work with them. Ms. Patrick stated she was not aware of other group applying. Mayor asked if could work together.

- D. Impact Fee Advisory Committee Appointment – Wayne Uehlin

A motion was made by Jensen to appoint Wayne Uehlin to the Impact Fee Advisory Committee. The motion was seconded by Heleker.

- E. Façade Grant Application –

1. Collaborative Effort of Payette National Register Properties:

Cleo Thompson, 75 N. Iowa Ave., Payette addressed the Council. She stated they have 10 of the 12 applications for the register plaques. They have told the people that it is not binding and they might not want to do. Once approved and placed there would be a map showing location of historic buildings. Jensen stated the last discussion was if this is for façade grant application, it is a good request, just not sure where we would get money. Discussed we had put money in economic development. Ms. Thompson stated it doesn't matter to her where the funding comes from, just that it gets funded. Mayor stated the funding for approved façade applications are being funded out of this year's budget. Nelson stated he likes the idea of the plaques, but doesn't think it should be tax payers money used. Heleker stated the entire Council is in favor of getting this done, but believes the main focus of the façade grant should be downtown buildings and improving them.

A motion was made by Dale and seconded by Jensen to fund the Collaborative Effort of Payette National Register Properties application through the façade grant program.

Jensen asked about building identification, is there a way to list a street address on the plaques. Barbara Wilson stated no one does, but could be done. Dale stated the two arguments the Council had were the building identification and that meets the criteria and the other was that it had to be \$1,000 and that is why they applied together. Mayor stated we are going to fund, just not sure from what fund. Heleker stated he is in favor just would like to have a different funding source. Jensen stated he thinks that it qualifies under the façade grant. Heleker disagreed, it is for the downtown corridor buildings.


