ORDINANCE NUMBER 1160

AN ORDINANCE OF THE CITY OF PAYETTE, IDAHO, ANNEXING CERTAIN REAL PROPERTY; DESCRIBING THAT REAL PROPERTY; SETTING AN EFFECTIVE DATE; ESTABLISHING SEVERABILITY; ESTABLISHING A REPEALER;

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF PAYETTE, IDAHO;

Section 1. The following described property is hereby annexed into and made a part of the City of Payette, Idaho.

Parcel I:

In South Park Subdivision:
In Block 1: lot 21.

In ASSESSOR'S WESTSLOPE PLAT, as per Plat in Book 1, Page 35, Plat Records, Payette County, Idaho:

In Block 40: Beginning at a point located 132 feet North and 276 feet West of the SE corner of the SW $\frac{1}{4}$ NW $\frac{1}{4}$ of Sec. 3, Twp. 8 N., R. 5 W., B.M., which point is located on the South bank of a certain irrigation ditch; thence West along said South bank 96 feet; thence North and parallel to the East side line of said SW $\frac{1}{4}$ NW $\frac{1}{4}$ 635 feet, more or less, to the center of that certain slough known as "49 Slough"; thence in a Southeasterly direction following the center line of said slough to a point due North of the point of beginning; thence South to the point of beginning;

ALSO,
In ROMINE SUBDIVISION as per Plat in Book 5, Page 1, Plat Records, Payette County, Idaho:

Lot 1.

Together with all water and water rights, ditches and ditch rights, tenements and hereditaments, appurtenances and fixtures, and permits and licenses belonging thereto or in anywise appertaining, including one (1) share of water stock in the Lower Payette Ditch Company.

Together with a 1966 Cranbrook 50-foot mobile home, I.D. No. 6FC5010F2N2826.

Together with all roads, streets and highways located therein or adjacent thereto.

Section 2. This Ordinance shall be in full force and effect immediately upon passage and publication as required by law.

Section 3. Any ordinances or resolutions which are in conflict with this ordinance are hereby repealed, but only insofar as the conflict exists.

Section 4. If any portion of this Ordinance should be found to be unconstitutional or unenforceable for any reason, the remainder of the Ordinance shall constitute Ordinance Number 1160.

Section 5. This Ordinance may be published by summary in accordance with the Statutes of the State of Idaho.


