

ORDINANCE NUMBER 1253

AN ORDINANCE OF THE CITY OF PAYETTE, IDAHO, AMENDING SECTION 8.08.110 BY INCREASING GARBAGE COLLECTION FEES; SETTING AN EFFECTIVE DATE; ESTABLISHING SEVERABILITY; ESTABLISHING A REPEALER; ALLOWING PUBLICATION BY SUMMARY;

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF PAYETTE, IDAHO;

Section 1. Section 8.08.110 is hereby to read as follows:

8.08.110: Collection Fees: Fees and rates for collection of refuse at residences shall be ~~Eight-Dollars-and-Fifty-Cents~~ Ten Dollars and Seventy Five Cents per month per dwelling unit, payable by the owner of the premises. Other rates are set as follows:

A. \$2.00 for each additional can over the three can limit.

B. \$2.35 for rental of a 95 gallon cart.

C. Commercial rates are set as follows:

There will be an additional charge if container is over loaded or over weight of 150 pounds per cubic yard.

D. The fees for other premises from which refuse is collected shall be set by negotiation and contract between the City and the owner or occupant. No charge will be made during the time the premises are vacant and no refuse is collected therefrom; provided, which period of time is not less than thirty days; and provided further, that notice of such vacancy shall be given in writing to the Clerk prior to such vacancy.

The fees established in this section shall be subject to modification, upon application to the Council by the owner or occupant, in all cases where fees so established shall be unjust or oppressive.

Section 2. This Ordinance shall be in full force and effect immediately upon passage and publication as required by law.

Section 3. Any ordinances or resolutions which are in conflict with this ordinance are hereby repealed, but only insofar as the conflict exists.

Section 4. If any portion of this Ordinance should be found be unconstitutional or unenforceable for any reason, the remainder of the Ordinance shall constitute Ordinance Number 1253.

Section 1. Section 8.08.110 is hereby to read as follows:

8.08.110: Collection Fees: Fees and rates for collection of refuse at residences shall be Ten Dollars and Seventy Five Cents per month per dwelling unit, payable by the owner of the premises. Other rates are set as follows:

- A. \$2.00 for each additional can over the three can limit.
- B. \$2.35 for rental of a 95 gallon cart.
