ANNUAL APPROPRIATIONS ORDINANCE
(AMENDED)**

AN ORDINANCE ENTITLED ANNUAL APPROPRIATIONS FOR THE TWELVE MONTH PERIOD FROM THE FIRST DAY OF OCTOBER 2006 TO AND INCLUSIVE OF THE THIRTIETH DAY OF SEPTEMBER, 2007, APPROPRIATING SEVEN MILLON, ~~FIVE~~ FOUR HUNDRED ~~THIRTYEIGHTY-FOUR~~ THOUSAND, SEVEN HUNDRED SIXTY-FIVE DOLLARS (~~\$7,534,765-7,484,765~~) TO PAY THE EXPENSES OF THE CITY OF PAYETTE, PAYETTE COUNTY, IDAHO, AND SPECIFYING THE OBJECTS AND PURPOSES FOR WHICH SAID APPROPRIATION IS MADE

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF PAYETTE, IDAHO:

Section 1. That the sum of ~~\$7,534,765~~ **7,484,765** be appropriated to defray the necessary expenses and liabilities for the City of Payette, Idaho, for the fiscal year beginning October 1, 2006.


