

ORDINANCE 1290

AN ORDINANCE OF THE CITY OF PAYETTE, IDAHO, AMENDING CHAPTERS 2.52.040 A of the PAYETTE MUNICIPAL CODE TO ALLOW FOR A MONTHLY STIPEND IN THE AMOUNT OF THIRTY FIVE DOLLARS (\$35.00) TO BE PAID TO PLANNING COMMISSIONERS FOR ATTENDANCE AT A MONTHLY PLANNING COMMISSION MEETING; SETTING AN EFFECTIVE DATE; ALLOWING PUBLICATION IN SUMMARY FORM; ESTABLISHING SEVERABILITY; ESTABLISHING A REPEALER

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF PAYETTE, IDAHO:

Section 1. The Payette Municipal Code is amended to hereby read as follows:

2.52.040 Compensation--Secretary--Meetings:

A. Members of the Planning Commission shall receive ~~no compensation~~ a monthly stipend in the amount of thirty-five dollars (\$35.00). Members of the Planning Commission who do not attend the regular monthly meeting of the Planning Commission, or if a Planning Commission meeting is not held in any one month, will not receive a stipend for that month.

B. The Planning Commission shall elect a secretary who need not be a member of the Commission. Such secretary shall keep an accurate record of all proceedings of the Commission and the Commission shall on the first Monday of May of each year make and file with the Council a report of all transactions of the Commission.

C. The Commission shall hold meetings at least once each calendar month and at such other times as may be necessary.

Section 2. This Ordinance may be published in summary form allowed by Idaho Code.

Section 3. This Ordinance shall be in full force and effect immediately upon passage and publication as required by the laws of the State of Idaho.


Section 4. Any ordinances or resolutions which are in conflict with this Ordinance are hereby repealed, but only insofar as the conflict exists.

Section 5. If any portion of this Ordinance should be found to be unconstitutional or unenforceable for any reason, the remainder of the Ordinance shall be applied to effectuate the purposes of this Ordinance.



SUMMARY OF ORDINANCE 1290

Ordinance 1290 is an ordinance of the City Of Payette, Idaho, adopted February 19, 2008. The ordinance may be descriptively known as the Payette ordinance authorizing payment of a monthly stipend to members of the Payette Planning Commission. Ordinance 1290 amends section 2.52.040(A) of the Payette Municipal Code to authorize the payment of a monthly stipend in the amount of thirty-five dollars (\$35.00) to Payette Planning and Zoning Commissioners for attendance at a monthly Planning & Zoning meeting. The Ordinance provides a severability clause, provides for publication by summary, sets an effective date, and establishes a repealer.
