

AN ORDINANCE AMENDING CHAPTER 15 SECTION 10-15-9 (D) TO PROVIDE THAT ANY VIOLATOR OF PARKING METER REGULATIONS MAY DEPOSIT CERTAIN SUMS OF MONEY IN AN ENVELOPE AND PLACE THE SAME IN CONTAINERS TO BE PLACED UPON THE STREETS OF PAYETTE, IDAHO, IN LIEU OF MAKING PAYMENTS TO THE CITY CLERK'S OFFICE AND TO FURTHER PROVIDE THAT WITHIN THE FIRST HOUR OF THE VIOLATION THE PENALTY WILL BE TWENTY-FIVE CENTS (25¢) INSTEAD OF FIVE CENTS (5¢).

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF PAYETTE, IDAHO, AS FOLLOWS:

That Chapter 15, Section 10-15-9 of the Ordinances of the City of Payette, Idaho shall be changed to read as follows:

Each such police officer shall attach to such vehicle a notice printed upon an envelope to the owner or operator thereof that such vehicle has been parked in violation of a provision of this Chapter and instructing such owner or operator to either deposit the required penalty in the envelope and drop it in a box to be erected for said purposes within the parking zone or report at the Clerk's office in the City with regard to such violation. Within the first hour (sixty (60) minutes) from the time written on the violation ticket or envelope, the violator may deposit in the meter at the Clerk's office, placed there for this purpose, or may deposit in the envelope and place said envelope in said container for said purposes, the sum of twenty-five cents (25¢), as a penalty for and in full satisfaction of such violation. Within the time of two hours (one hundred twenty (120) minutes) from the time written on the violation ticket the violator may in person present to the Clerk's office or police officer the sum of fifty cents (50¢) or may deposit fifty cents (50¢) in the coin envelope and deposit the same in the special container hereinbefore mentioned *****, as a penalty for and in full satisfaction of such violation.

If the payments as aforesaid are paid to the Clerk's office, and if such violation occurred after the hour of 4:00 P.M. on any day Monday through Friday, or after the hour of 11:00 A.M. on Saturday of any week, the violator shall have until 11:00 A.M. of the following day to deposit ~~in~~ the meter at the Clerk's office the sum of twenty-five cents (25¢) as above set forth, or until 12:00 noon the following day to pay the sum of fifty cents (50¢) as above set forth. Any owner or operator who fails to make payment in either of the above prescribed manners, may within the period of twenty-four (24) hours following such violation pay at the Clerk's office the sum of one dollar (\$1.00) as a penalty for and in full satisfaction of such violation. If the day following the violation be a Sunday or legal holiday, the violator may on the first business day following the violation comply with the above regulations. The failure of such owner or operator to make such payment within said twenty-four (24) hour period shall render such owner or operator subject to the penalties prescribed in Title I, Chapter 3 of this Code.
