

ORDINANCE NO. 684

AN ORDINANCE MAKING AN ANNUAL APPROPRIATION AND LEVY FOR GENERAL, STREET LIGHTING, LIBRARY, FIRE EQUIPMENT, RECREATION, L.I.D. GARANTEE FUND, BOND INTEREST, BOND SINKING, SEWER AND STORM SEWERS, AIRPORT, STREET SPRINKLING, FLUSHING AND OILING, OFF-STREET PARKING.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF PAYETTE, IDAHO.

SECTION 1. That the sum of \$203,800, together with fines, forfeitures and other money not otherwise appropriated, is hereby appropriated for the General Expenses of the City of Payette, Idaho, for the fiscal year commencing on the first day of January, 1965.

SECTION 2. That the sum of \$15,862.51 is hereby appropriated for the purpose of lighting the Streets and Avenues and thoroughfares of the City of Payette, Idaho and the same shall constitute the Street Lighting Fund.

SECTION 3. That there is hereby appropriated for the fiscal year commencing with the first day of January 1965, the sum of \$15,634.44 for the purpose of maintaining a Public Library and the same shall constitute the Library Fund.

SECTION 4. That the sum of \$5,515.58 is hereby appropriated for the Fire Equipment Fund commencing with the first day of January 1965, for the purpose of maintaining the Fire Department and the same shall constitute the Fire Equipment Fund.

SECTION 5. That there is hereby appropriated for the fiscal year commencing with the first day of January 1965 the sum of \$12,120.69 for the purpose of maintaining a Recreation program and the same shall constitute the Recreation Fund.

SECTION 6. That there is hereby appropriated for the fiscal year commencing with the first day of January 1965 the sum of \$5,642.19 for the purpose of maintaining a Off-Street Parking program and the same shall constitute the Off-Street Parking Fund.

SECTION 7. That there is hereby appropriated for the fiscal year commencing with the first day of January 1965 the sum of \$9,732.95 for the purpose of maintaining the L.I.D. Garantee Fund for the City of Payette and the same shall constitute the Local Improvement District Fund.

SECTION 8. That there is hereby appropriated for the fiscal year commencing with the first day of January 1965 the sum of \$2,282.70 for the purpose of paying interest on all outstanding general obligation bonds of the City of Payette, Idaho and the same shall constitute the Bond Interest Fund.

SECTION 9. That there is hereby appropriated for the fiscal year commencing with the first day of January 1965 the sum of \$13,903.01 for the purpose of maintaining the Sewer Maintenance and Storm Sewers of the City of Payette and the same shall constitute the Sewer Maintenance and Storm Sewer Fund.

SECTION 10. That the sum of \$4,341.85 is hereby appropriated for the fiscal year commencing with the first day of January 1965 for the purpose of maintaining an Airport for the City of Payette and the same shall constitute the Airport Fund.

SECTION 11. That the sum of \$9,523.81 is hereby appropriated for the fiscal year commencing with the first day of January 1965 for the purpose of Street sprinkling, Flushing and Oiling and the same shall constitute the Street Sprinkling, Flushing and Oiling Fund.

SECTION 12. That the sum of \$13,661.87 is hereby appropriated for the fiscal year commencing with the first day of January 1965 for the redemption of the outstanding General Obligation Bonds of the City of Payette, Idaho and the same shall constitute the Bond Sinking Fund.

SECTION 14. That there is hereby levied for the fiscal year commencing with the first day of January 1965 the sum of Thirty (30) mills on each one dollar of the assessed valuation of all the taxable property within the corporate limits of the City of Payette, Idaho and the funds realized from such levy together with all fines, licenses, forfeitures and money not otherwise appropriated shall be for and constitute the General Funds of the City of Payette, Idaho.

SECTION 15. That there is hereby levied for the fiscal year commencing with the first day of January 1965 the sum of Five and four tenths (5.4) mills on each one dollar of the assessed valuation of all the taxable property within the corporate limits of the City of Payette, Idaho and the funds realized from such levy shall be and the same shall constitute the Street Lighting Fund.

SECTION 16. That there is hereby levied for the fiscal year commencing with the first day of January 1965 the sum of Four and two-tenths (4.2) mills on each one dollar of the assessed valuation of all the taxable property within the corporate limits of the City of Payette, Idaho and the funds realized from such levy shall be and the same shall constitute the Library Fund.

SECTION 17. That there is hereby levied for the fiscal year commencing with the first day of January 1965 the sum of Two (2.) mills on each one dollar of the assessed valuation of all the taxable property within the corporate limits of the City of Payette, Idaho and the funds realized from such levy shall be and the same shall constitute the Fire Equipment Fund.

SECTION 18. That there is hereby levied for the fiscal year commencing with the first day of January 1965 the sum of Two and five-tenths (2.5) mills on each one dollar of the assessed valuation of all the taxable property within the corporate limits of the City of Payette, Idaho and the funds realized from such levy shall be and the same shall constitute the Recreation Fund.

SECTION 19. That there is hereby levied for the fiscal year commencing with the first day of January 1965 the sum of One (1.0) mill on each one dollar of the assessed valuation of all the taxable property within the corporate limits of the City of Payette, Idaho and the funds realized from such levy shall be and the same shall constitute the Local Improvement District Fund.

SECTION 20. That there is hereby levied for the fiscal year commencing with the first day of January 1965 the sum of Four-tenths (0.4) mill on each one dollar of the assessed valuation of all the taxable property within the corporate limits of the City of Payette, Idaho and the funds realized from such levy shall be and the same shall constitute the Bond Interest Fund.

SECTION 21. That there is hereby levied for the fiscal year commencing with the first day of January 1965 the sum of Two (2.0) mills on each one dollar of the assessed valuation of all the taxable property within the corporate limits of the City of Payette, Idaho and the funds realized from such levy shall be and the same shall constitute the Sewer Maintenance and Storm Sewer Fund.

SECTION 22. That there is hereby levied for the fiscal year commencing with the first day of January 1965 the sum of One (1.0) mill on each one dollar of the assessed valuation of all the taxable property within the corporate limits of the City of Payette, Idaho and the funds realized from such levy shall be and the same shall constitute the Airport Fund.

SECTION 23. That there is hereby levied for the fiscal year commencing with the first day of January 1965 the sum of Nine-tenths (0.9) mill on each one dollar of the assessed valuation of all the taxable property within the corporate limits of the City of Payette, Idaho and the funds realized from such levy shall be and the same shall constitute the Street Sprinkling, Flushing and Oiling Fund.

SECTION 24. That there is hereby levied for the fiscal year commencing with the first day of January 1965 the sum of Five-tenths (0.5) mill on each one dollar of the assessed valuation of all the taxable property within the corporate limits of the City of Payette, Idaho and the funds realized from such levy shall be and the same shall constitute the Bond Sinking Fund.
