An Ordinance

AN ORDINANCE ANNEXING ADJOINING LANDS TO THE CITY OF PAYETTE, IDAHO:

Be It Ordained by the Mayor and the City Council of the City of Payette, State of Idaho:

That the following described real property adjoining or touching the limits of the City of Payette and located in the County of Payette, State of Idaho, are hereby added to, taken into, annexed and made a part of the City of Payette, Idaho, and zoned "C" Commercial District.

In the County of Payette, State of Idaho:

A parcel of real property situated in Block 6 of the Recorder's Plat to Section 34, Township 9 North, Range 5 West of the Boise Meridian, which Plat is on file in Book 2 of Plats, at Page 5, in the Office of the Recorder of Payette County, Idaho. The parcel is more particularly described as follows:

Commencing at the NW Corner of said Block 6;

Thence South 0° 06' 15" East, along the West boundary of said Block 6, a distance of 148.00 feet to the TRUE POINT OF BEGINNING;

Thence North 89° 58' 40" East, along the South boundary of the right-of-way for 3rd Avenue North as it is presently situated, a distance of 390.76 feet;

Thence South 0° 01' 00" East, a distance of 411.14 feet;

Thence South 89° 59' 30" West, a distance of 390.14 feet to a point on the West boundary of said Block 6;

Thence North 0° 06' 15" West, along the West boundary of said Block 6, a distance of 411.05 feet to the TRUE POINT OF BEGINNING.

This parcel contains 3.69 acres.


