AN ORDINANCE

AN ORDINANCE AMENDING SECTION 1-22-1 OF THE MUNICIPAL CODE OF THE CITY OF PAYETTE, IDAHO BY PROVIDING FOR ADDITIONAL VACATION LEAVE FOR CERTAIN EMPLOYEES AND OFFICERS OF THE CITY OF PAYETTE, IDAHO.

Be it ordained by the Mayor and Council of the City of Payette, Idaho that Section 1-22-1 of the Municipal Code of the City of Payette is amended as follows:

Section 1-22-1: VACATIONS AND SICK LEAVE: The appointed officers and employees of the City shall have vacations and sick leave on full pay as follows:

(A) (1) For those appointed officers and employees who have been continuously employed by the City of Payette, Idaho since January 15, 1972, and who continue to be so employed by the City of Payette, Idaho: One and one-fourth ($1\frac{1}{4}$) days vacation for each month during which the employee or officer has worked for the City ~~during the fiscal year~~; and one and one-fourth ($1\frac{1}{4}$) days sick leave for each month that the employee or officer has worked for the City; and one and two thirds ($1\frac{2}{3}$) days vacation for each month during the sixteenth and following year periods the employee or officer has worked for the City during the fiscal year, provided, however, that the employee or officer shall not be entitled to vacation leave earned until after the completion of the fiscal year employment for the year period in which the leave was earned.

(A) (2) For those appointed officers and employees who have not been employed continuously by the City of Payette, Idaho since January 15, 1972: Five-twelfths ($5/12$) days vacation for each month during the first fiscal year period the employee or officer has worked for the City; Five-sixths ($5/6$) days vacation for each month during the second through the ninth seventh year periods the employee or officer has worked for the City, ~~And~~ one and one-fourth ($1\frac{1}{4}$) days vacation for each month during the eighth through the fifteenth year periods ~~tenth and following fiscal years~~ the employee or officer has worked for the City; and one and two thirds ($1\frac{2}{3}$) days vacation for each month during the sixteenth and following year periods the employee or officer has worked for the City; And one and one-fourth ($1\frac{1}{4}$) days sick leave for each month that the employee or officer has worked for the City during the fiscal year, provided, however, that the employee or officer shall not be entitled to vacation leave earned until after the completion of the fiscal year employment for the year period in which the leave was earned.

(B) All vacations shall be taken after the fiscal year period ^(or Mayor) during which the vacation has been earned; the time that the employee or officer shall take his vacation shall be prearranged with the City administrator; and vacation leave shall not accumulate; however, one-third ($1/3$) of that part of the total sick leave unused by the employee during the any year shall accumulate, but shall not exceed a total of thirty (30) days; and provided further, that such accumulation shall be in addition to any sick leave earned by such employee or officer in the following year of employment ~~any other year~~.

This Ordinance shall take effect and be in force from and after its publication in the Independent Enterprise, a newspaper of general circulation in the City of Payette, Idaho.
