

AN ORDINANCE ANNEXING Real property to the City of Payette, Idaho and zoning the same "A" Residential.

BE IT ORDAINED BY the Mayor and Council of the City of Payette, Idaho, that the following described real property be annexed to the City of Payette, Idaho and zoned "A" Residential.

In the County of Payette, Idaho:

This parcel is situated in the SE $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 3, Township 8 North, Range 5 West of the Boise Meridian and is more particularly described as follows:

COMMENCING at the Northeast corner of Government Lot 1 of said Section 3;

Thence South 0°23'32" West, (formerly South), along the East boundary of said Government Lot 1, a distance of 1052.76 feet to a point which is the Southeast corner of said Government Lot 1 and the Northeast corner of said SE $\frac{1}{4}$ NE $\frac{1}{4}$;

Thence North 89°48'38" West, along the South boundary of said Government Lot 1 and the North boundary of said SE $\frac{1}{4}$ NE $\frac{1}{4}$, a distance of 1018.02 feet to the centerline of Hughes Drive and the TRUE POINT OF BEGINNING;

Thence South 28°42'48" East along the centerline of Hughes Drive, a distance of 125.00 feet;


Thence North 89°48'38" West along a line parallel with the North boundary of said SE $\frac{1}{4}$ NE $\frac{1}{4}$, a distance of 231.98 feet;

Thence North 28°42'48" West, along the boundary of Hughes Drive, a distance of 125.00 feet to a point on the North boundary of said SE $\frac{1}{4}$ NE $\frac{1}{4}$;


Thence South 89°48'38" East, along the North boundary of said SE $\frac{1}{4}$ NE $\frac{1}{4}$ a distance of 231.98 feet to the centerline of Hughes Drive and the TRUE POINT OF BEGINNING.

That this ordinance shall be in full force and effect from and after its publication in the Independent Enterprise, a newspaper of general circulation in the City and County of Payette, Idaho.
