

ORDINANCE NO. 205 BY

AN ORDINANCE GRANTING TO THE GREENWOOD AVENUE IRRIGATION COMPANY, LIMITED, A CORPORATION THE RIGHT, PRIVILEGE, ~~AND~~ FRANCHISE AND AUTHORITY TO BUILD, OPERATE, AND MAINTAIN WATER PIPE LINES AND WATER SYSTEMS THROUGH THE STREETS AND ALLEYS OF THE CITY OF PAYETTE LYING ALONG 7TH AVE. NORTH AND ALL PARTS OF THE CITY LYING NORTH THEREOF.

Be it ordained by the Mayor and Council of the City of Payette:

Section 1. That there be and hereby is granted to the Greenwood Avenue Irrigation Company, Limited, <sup>a corporation,</sup> its successors and assigns the right, privilege and authority to build, operate and maintain water pipe lines and water systems for the purpose of conveying and distributing water for irrigation purposes ~~purposes~~ only, to its stockholders, on lands in said City of Payette, Idaho, lying North of 7th Avenue North.

Section 2. The main line and laterals of said water pipe line and water system shall be properly constructed and maintained by said Greenwood Avenue Irrigation Company, Limited, not less than two feet underground and the waters therein conducted shall not be ~~xxx~~ permitted to flood or in any way damage the streets and alleys of the said City. Said pipe line shall be located near the curb line in streets, under the direction of the Mayor and Council of said City and under the direction of the Mayor and Council, when placed in alleys.

Section 3. The main line of said pipe line shall be located along 7th Avenue North, beginning at the Eastern limits of said City, running thence West along said <sup>Avenue</sup> so far as may be necessary to convey water to its stockholders, with laterals running along any of the streets or alleys lying North of said 7th Avenue North.

Section 4. Said pipe line and water system shall be so constructed as to not interfere with any other ~~other~~ pipe, sewer, conduit or other pipe lawfully entitled to be in any of said streets or alleys. The said Greenwood Avenue Irrigation Company, Limited shall forever save the said City of Payette harmless ~~and indemnify~~ from any liability or damages it.

~~Section 5. The rights and privileges <sup>granted by</sup> of this franchise shall run for a period twenty five years, unless sooner revoked for cause.~~

Section ~~5~~. This ordinance and franchise shall be in full force and effect from and after its passage, approval and publication in the official newspaper.
