

ORDINANCE No. 344

AN ORDINANCE AUTHORIZING THE ISSUING OF IMPROVEMENT bonds of Local Improvement District No. 4 of the City of Payette, Idaho, in an amount not exceeding \$45,600.00, for the purpose of paying the cost of grading, paving, curbing and surface-draining certain streets and avenues, and parts of streets and avenues, of said District, and providing for the payment thereof by levying a special assessment against the abutting, adjoining, contiguous or proximate property in said District liable to assessment for such improvement.

WHEREAS, The Mayor and Council of the City of Payette, Idaho, have heretofore, under the authority vested in them by the laws of the State of Idaho, caused the streets and avenues in Local Improvement District No. 4 of said City to be improved;

AND, WHEREAS, for the purpose of paying the cost and expense of which is chargeable and has been assessed to the abutting, adjoining, contiguous or proximate property in said Local Improvement District No. 4 of the City of Payette, Idaho, the Mayor and Council have in their discretion heretofore provided for the payment of the cost and expenses thereof by installments instead of levying the entire tax of special assessments for such costs at one time;

NOW, THEREFORE, BE IT OBTAINED BY THE MAYOR AND COUNCIL OF THE CITY OF PAYETTE, IDAHO, AS FOLLOWS:

Section 1. That for the aforesaid installments therein to be issued in the name of the City of Payette, Idaho, improvement bonds of Local Improvement District No. 4, which shall include the adjoining, contiguous and proximate property liable to assessment for such local improvements, payable in installments of equal amount each year, which bonds shall by their terms be made payable on or before a date not to exceed ten years from and after the date of the issue of such bonds, to-wit: on or before the first day of August, 1931, which said bonds shall bear interest at the rate of seven percent per annum, payable semi-annually, on the first days of January and July in each year, which said bonds shall be issued in an amount not to exceed the sum of \$45,600.00; the definite amount of said bonds to be determined at the time of the issuance thereof, it being the express intent hereof to only authorize bonds in an amount not to exceed such sum as may be legally issued at the time provided by law for the issuance thereof.

Section 2. Said bonds shall be known and designated as "City of Payette Local Improvement District No. 4 Improvement Bonds" and shall not be issued in excess of the contract price and the expense of such improvement, including engineering and other clerical services, advertising, cost of inspection, cost of collecting assessments and interest upon warrants, if issued, and the installment coupon, shall include interest to the maturity thereof.

Section 3. Said bonds shall be of the following denominations: Forty of said bonds of said issue shall be in the denomination of \$1,000.00; Ten of said bonds of said issue shall be in the denomination of \$500.00; Six of said bonds of said issue shall be of the denomination of \$100.00.

that is, if the full amount hereinbefore authorized is issued; Provided, however, that if the full amount be not issued the bonds of \$1000.00 denomination shall be correspondingly reduced.

Section 4. Said bonds shall be dated the first day of July 1921, and shall be payable on or before the first day of August 1931, and shall bear interest at seven percent per annum from the date thereof, payable semi-annually on the first days of January and July of each year, both principal and interest to be payable in gold coin of the United States of the present standard of value, at the office of the City Treasurer of the City of Payette, Idaho, or at the Chase National Bank in the City and State of New York.

Section 5. Such bonds shall be numbered from one upwards and each bond and coupon shall be signed by the Mayor, countersigned by the City Treasurer, and attested by the Clerk of the City of Payette, Idaho; provided however, that such coupons may in lieu of being signed have printed thereon the facsimile of the signature of said officers, and each bond shall have the seal of such City affixed thereto, and shall refer to the Improvement District for the payment of which the same shall be issued. Each bond shall provide that the principal sum therein named, and the interest thereon shall be payable out of the Local Improvement fund created for the payment of the cost and expense of such improvement, and not otherwise.

Section 6. Said bonds and coupons shall be substantially in the following form:

for the improvement for which said bond was issued, but his remedy, in case of non-payment, shall be confined to the enforcement of such assessments.

Whenever there shall be sufficient money in the local improvement fund against which this bond has been issued over and above the amount sufficient for the payment of interest on all unpaid bonds of this series, to pay the principal of one or more bonds, this bond shall be called in and paid in its numerical order; provided, that such call shall be made by publication in the City official newspaper on the day following the delinquency of any installment of the assessment or as soon thereafter as practicable in the form and manner provided by law.

For the collection of the assessments levied in said Local Improvement District No. 4, the City of Payette, County of Payette, State of Idaho, hereby pledges the exercise of all lawful corporate powers.
