WHEREAS the City Council of the City of Payette, Idaho, is aware that records must occasionally be destroyed to make room for incoming records; and


WHEREAS the City has regularly been audited and has retained audit reports of the records which should be destroyed; and


WHEREAS the city council has been advised that records may be destroyed only after they have been audited and must be listed in detail and destroyed under the direction and supervision of the City Clerk;
