ORDINANCE 1055

AN ORDINANCE OF THE CITY OF PAYETTE, IDAHO, ANNEXING THAT REAL PROPERTY WHICH IS DESCRIBED IN SECTION 1; ESTABLISHING ZONING; PROVIDING SEVERABILITY; REPEALER; EFFECTIVE DATE;

Be it ordained and resolved by the Mayor and City Council of the City of Payette, Idaho.

Section 1: That real property be annexed into the City of Payette, Idaho, which is real property being a portion of Bell Place Plat in the records of the Payette County Assessor, Payette County, Idaho and in the NW 1/4, SW 1/4 of Section 35, Township 9 North, Range 5 West, B.M. and is more particularly described as follows;

Parcel No. 1: Block 1, Lots 1 thru 10.

Parcel No. 2: The North 33 feet of the NW 1/4, SW 1/4 of Section 35, Township 9 North, Range 5 West.

Section 2: The properties shall be zoned A-Residential.

Section 3: If any portion of the Ordinance is found to be unenforceable or unconstitutional for any reason, the remaining portion of the Ordinance shall remain in full force and effect.

Section 4: Any portions of any existing Ordinances which are in conflict with this Ordinance are hereby repealed insofar as the conflict exists.

Section 5: This Ordinance shall take effect and be in full force and effect after its adoption and publication as required by law.

BE IT ORDAINED AND RESOLVED THAT THIS ORDINANCE SHALL BE IN FULL FORCE AND EFFECT FROM AND AFTER ITS A APPROVAL, PASSAGE, AND PUBLICATION AS REQUIRED BY LAW.

This Ordinance shall be in full force and effect, on the 16th day of November, 1992.


