

ORDINANCE NUMBER 1153

AN ORDINANCE OF THE CITY OF PAYETTE, IDAHO, ANNEXING CERTAIN REAL PROPERTY; DESCRIBING THAT REAL PROPERTY; SETTING AN EFFECTIVE DATE; ESTABLISHING SEVERABILITY; ESTABLISHING A REPEALER;

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF PAYETTE, IDAHO;

Section 1. The following described property is hereby annexed into and made a part of the City of Payette, Idaho.

Parcel I:

In South Park Subdivision:

In Block 1: lots 10 through 20 and the West 20 feet of lot 8.

In Block 2: Lots 5 and 6.

Block 3.

In Block 4: Lots 5 through 8.

Block 5.

Parcel II:

In DeWitt's First Subdivision:

Blocks 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, and 12:

Block 12 also being more particularly described as lots 1 through 12 of Rudd's Subdivision of Block 12 of DeWitt's Subdivision.

Parcel III:

In West Slope Subdivision:

The South one hundred and thirty two 132 feet of lot 41 of West Slope Subdivision.

Together with all roads, streets and highways located therein or adjacent thereto.

Including that portion of Sixth Avenue South lying South of the centerline of Sixth Avenue South adjacent to and North of Blocks 1, 6 and 7 of DeWitt's First Subdivision.

Also including South 11th and South 12th Streets.

Section 4. This Ordinance shall be in full force and effect immediately upon passage and publication as required by law.


