

ORDINANCE NUMBER 1252

AN ORDINANCE OF THE CITY OF PAYETTE, IDAHO, REPEALING CHAPTER 8.04 OF TITLE 8 OF THE PAYETTE CITY CODE; REPEALING CONFLICTING ORDINANCES; ALLOWING PUBLICATION BY SUMMARY; SETTING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF PAYETTE, IDAHO:

SECTION 1: Chapter 8.04 of Title 8 of the Payette City Code is hereby repealed.

SECTION 2: Any ordinances or resolutions which are in conflict with this ordinance are hereby repealed, but only in-so-far as the conflict exists.

SECTION 3: This ordinance may be published in summary form.

SECTION 3: This Ordinance shall be in full force and effect immediately upon passage and publication as required by law.

ORDINANCE NUMBER 1252

AN ORDINANCE OF THE CITY OF PAYETTE, IDAHO, RENUMBERING SECTION 10.20.100 C AS SECTION 10.20.100 D. AND CREATING A NEW SECTION 10.20.100 C.; SECTION 10.20.100 C PROHIBITS CROSSING THE CENTERLINE ON MAIN STREET TO PARK OR LEAVE A PARKING SPACE; MAKING A VIOLATION OF 10.20.100 C. AN INFRACTION; REPEALING CONFLICTING ORDINANCES; SETTING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF PAYETTE, IDAHO:

Section 1: A new Section 10.20.100 C. is hereby created and shall read as follows:

Section: 10.20.100 C. It shall be unlawful for any driver to cross the center line on Main Street between Third Avenue North and Business 95 for the purpose of entering or leaving a parking space.

Section 2: Section 10.20.100 C. of the Payette Municipal Code is hereby renumbered as Section 10.20.100 D. and the new section 10.20.100 D. Shall read as follows;

Section 10.20.100 D. A violation of subsection A, B or C shall be an infraction.

SECTION 3: Any ordinances or resolutions which are in conflict with this ordinance are hereby repealed, but only in-so-far as the conflict exists.

SECTION 4: This Ordinance shall be in full force and effect immediately upon passage and publication as required by law.
