

RESOLUTION NO. 2017-04

A RESOLUTION OF THE CITY OF PAYETTE, IDAHO, ADOPTING AND SETTING CERTAIN FEES WHICH SHALL BE CHARGED BY THE PAYETTE CITY BUILDING OFFICIAL.

WHEREAS, before an applicant can obtain a permit as prescribed in the Payette Municipal Code, the appropriate fees must be paid; and,

WHEREAS, the Payette Municipal Code, Section 15.04.010, adopts by reference the most recent edition of the International Building Code (IBC); and,

WHEREAS, the IBC now requires permit fees to be set in accordance with a schedule as established by the governing body; and,

WHEREAS, these fees have been determined to be necessary and sufficient to compensate for the time and expense for processing the building permits.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF PAYETTE, IDAHO;

Section 1: The following fees are hereby adopted and those fees shall be charged by the Payette City Building Official.

Building permit fees are based on the values as shown in Chapter 1, Table 1-A of the 2017 Uniform Building Code as shown below:

Total Valuation	Fee
\$1.00 to \$500.00	\$24
\$501.00 to \$2,000.00	\$24 for the first \$500; plus \$3.00 for each additional \$100 or fraction thereof, up to and including \$2,000.00
\$2,001.00 to \$40,000.00	\$69 for the first \$2,000; plus \$11.00 for each additional \$1,000 or fraction thereof, up to and including \$40,000.00
\$40,001.00 to \$100,000.00	\$487 for the first \$40,000 plus \$9.00 for each additional \$1,000 or fraction thereof, up to and including \$100,000.00
\$100,001.00 to \$500,000.00	\$1,027 for the first \$100,000 plus \$7.00 for each additional \$1,000 or fraction thereof, up to and including \$500,000
\$500,001.00 to \$1,000,000.00	\$3,827 for the first \$500,000 plus \$5.00 for each additional \$1,000.00, or fraction thereof, up to and including \$1,000,000.00
\$1,000,001.00 to \$5,000,000.00	\$6,327 for the first \$1,000,000.00 plus \$3.00 for each additional \$1,000, or fraction thereof, up to and including \$5,000,000
\$5,000,001.00 and up	\$18,327 for the first \$5,000,000 plus \$1.00 for each additional \$1,000.00 or fraction thereof

Minimum inspection fee

\$50.00


For the purpose of determining the building permit fee, estimated cost of construction shall be determined by the building official.


Section 2. This resolution supersedes and replaces any portions of any resolutions which conflict with the fee schedule adopted herein.
