

ORDINANCE NO. 598⁶

AN ORDINANCE SUBMITTING TO THE QUALIFIED ELECTORS OF THE CITY OF PAYETTE, WHO ARE TAX PAYERS THEREOF, AT A SPECIAL ELECTION TO BE HELD ON TUESDAY THE 18TH DAY OF ~~SEPTEMBER~~^{OCTOBER}, 1956, THE QUESTION OF ISSUING THE GENERAL OBLIGATION BONDS OF THE CITY OF PAYETTE FOR THE IMPROVEMENT OF PARKS BY THE ADDITION OF FILTERING AND HEATING EQUIPMENT AND OTHER MISCELLANEOUS ITEMS TO THE SWIMMING POOL AT THE TOTAL ESTIMATED COST OF NOT MORE THAN \$30,000.00; SAID BONDS TO RUN FOR A PERIOD OF TWENTY YEARS FROM DATE OF ISSUE; SPECIFYING THE MAXIMUM RATE OF INTEREST WHICH SAID BONDS SHALL BEAR, AND OTHER DETAILS OF SAID BOND ISSUE; PROVIDING FOR THE NOTICE OF SUCH ELECTION AND FOR THE PUBLICATION AND POSTING THEREOF AND PROVIDING FOR THE PUBLICATION OF THIS ORDINANCE AND THE EFFECTIVE DATE THEREOF.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF PAYETTE, IDAHO:

Section 1. WHEREAS, the municipal swimming pool located in the Harris-Kiwanis Park is in need of filtering, heating and other miscellaneous equipment, at the estimated amount of \$30,000.00 ; that improvements to said swimming pool will constitute a park improvement; and Whereas, reliable estimates place the cost of purchasing, constructing, installing, improving and doing all the things above described for the sum of \$30,000.00 .

Section 2. NOW, THEREFORE, The Mayor and Council of the City of Payette, State of Idaho, recognize that it is for the best welfare and interest of the City to issue municipal coupon bonds of said City, as hereinafter provided, for the purpose of raising the necessary funds to cover the needs of the City, as outlined above, do hereby call a special election of the qualified electors, who are tax payers of the City of Payette, Idaho, to be held on the ~~18th~~^{2nd} day of ~~September~~^{October}, 1956, between the hours of 9:00 o'clock A.M. and 7:00 o'clock P.M., Mountain Standard Time, of said day, for the purpose of submitting to the qualified electors, who are tax payers of said City, the question of the issuance of the general obligation bonds of the City of Payette for the purpose set forth in the next section of this Ordinance.

Section 3. Said bonds shall be issued for the total principal sum of not more than \$30,000.00 , to be used by the City of Payette for the purpose of providing funds for park improvement in the Harris-Kiwanis Park by purchasing, constructing, and installing filtering, heating and other miscellaneous

as amended, known as "Municipal Bond Law", the first annual amortized principal payment shall mature and be payable at the expiration of two years from and after the date of issue, and the various annual maturit^{ies} shall as nearly as practicable be in such principal amounts as will, together with the accruing interest on all outstanding bonds, be met and paid by an equal annual tax levy for the payment of the principal of such authorized issue of such bond and interest thereon during the term such bonds shall be issued.

Section 5. The Mayor and Council of the City shall levy and cause to be levied annually, at the time and in the manner in which other general taxes of such city are levied, upon all the taxable property within the limits of the City of Payette, Idaho, in addition to all other authorized taxes and assessments, a tax or assessment sufficient to meet the payments of principal and interest on such bonds as the same mature, and to constitute a sinking fund for the payment of the principal of such bond issue within twenty years from date of contracting the indebtedness evidenced by such bond issue, and in accordance with the provisions made for the payment of the principal and interest of such bond issue; and such taxes shall be levied, assessed, certified and extended and collected by the proper officers and at the times, all as fixed by law and as other taxes are levied, assessed, certified, extended and collected, for and by the City, and by the same officers thereof, until the principal and interest of all such bonds shall be fully paid.

Section 6. Such municipal coupon bonds shall be in denominations of \$100.00 each, or any multiple thereof not exceeding \$1,000.00, as shall be fixed by future ordinance to be passed by the mayor and council of the City prior to the issuance of such bonds, and all such bonds shall bear interest at a rate or rates not exceeding 5 % per annum as shall be fixed by future ordinance prior to the issuance of such bonds, which interest shall be payable semi-annually on the dates likewise to be fixed by future ordinance prior to the issuance of any such bonds, and such bonds shall be issued in conformity with and after full compliance with the Constitution of the State

within the City of Payette, Idaho, shall be and will continue to be pledged for and until the entire principal and interest of all of such bonds have been paid in full, and the bond form and the coupon form shall be prescribed by the Mayor and the City Council by future ordinance prior to the delivery of such bonds to the purchaser thereof.

Section 7. The City Clerk of the City is hereby directed and authorized to give notice of the above described election by publication of such notice in The Independent-Enterprise, a weekly newspaper printed and published in the City of Payette, Idaho, and having a general circulation therein, such notice to be published for a period of not less than thirty (30) days previous to the said election, and said election shall be conducted as other municipal elections.

Said notice of said election to be given by the City Clerk shall be substantially in the following form:

Pursuant to the "Municipal Bond Law" of the State of Idaho, and Ordinance No. 593 596, passed by the Mayor and Council of the City of Payette, Idaho, and approved on the 6th day of August, 1956, Notice is hereby given that a special election will be held within the City of Payette, Idaho, on Tuesday, the 18th day of September, 1956, beginning at the hour of 9:00 o'clock A.M., and will close at the hour of 7:00 o'clock P.M. of said day, for the purpose of submitting to the qualified electors of said City, who are tax payers thereof, the following question: 'Whether or not the City of Payette shall incur an indebtedness and issue its municipal coupon bonds in the principal sum of not more than \$50,000.00 for the purpose of improving the Public Park of the City of Payette, Idaho, by purchasing, constructing, installing filtering, heating and other miscellaneous equipment at the municipal swimming pool, as provided in the general plans on file in the office of the City Clerk of the said City, and also as provided for in Ordinance No. 593 596 of said City, to which said plans and ordinance reference is hereby made.

All persons, who, at the time of said election, are qualified electors of the City of Payette and tax payers thereof, and who are registered, shall be qualified to vote at said election on said question. The voting at said election will be by ballot and the ballots shall be supplied said voters at the polls in said election and shall be as set forth in said Ordinance No. 593 .596.

NOTICE OF REGISTRATION

NOTICE IS HEREBY GIVEN That there are three Wards within the corporate limits of the City of Payette, Idaho, and that said Wards are designated, bounded and described as follows, to-wit:

FIRST WARD: All of that portion of said City of Payette, Idaho, lying North of the Center line of Center Avenue and East of the Center line of the main track of the Union Pacific Railroad.

SECOND WARD: All of that portion of said City of Payette, Idaho, lying South of the Center line of Center Avenue and East of the Center line of the main track of the Union Pacific Railroad.

THIRD WARD: All of that portion of the City of Payette, Idaho, lying West of the center line of the main track of the Union Pacific Railroad.

NOTICE IS HEREBY FURTHER GIVEN That the name of the Registrar is as follows, to-wit:

You are hereby further notified that all persons must register before said special election to be entitled to vote regardless of whether or not they have at any time before the publication of this notice registered for any city election of the City of Payette, Idaho.

All persons over the age of twenty-one (21) years, who, at the time of said election are citizens of the United States of America and have resided in the State of Idaho for a period of six months and in the City of Payette for a period of three months immediately preceding said election and are taxpayers of the City of Payette are entitled to vote at said Election, provided such electors are duly registered for said Election as required by law.

NOTICE IS HEREBY FURTHER GIVEN That the place of registration for each and all of said wards of the City of Payette is the Office of the City Clerk of the City of Payette, in the City Hall, at the corner of 8th Street and 3rd Avenue North in said City of Payette.

NOTICE IS HEREBY FURTHER GIVEN That the Registrar will register any qualified elector (who is a taxpayer) of the City of Payette desiring to be registered in the above designated place of registration and at any time during office hours beginning with the day that this notice of Election is given and each and every day thereafter until and including the 15th day of September, 1956; that on Thursday, Friday and Saturday next preceding said election, being the 13th, ^{27th} 14th and 15th days of September, 1956, the said Registrar shall and will, at the place above designated, register qualified electors (who are taxpayers) of the City of Payette, Idaho, for such

Section 8. The voting at said election shall be by ballot and the ballots shall be so prepared as to permit the qualified electors to express their desire on the issue in substantially the following form:

Section 9. The voting places shall be the places provided in the notice herein in this ordinance contained and the persons named in said notice are hereby appointed judges and distributing clerks of said election respectively for the purpose of conducting the same in their respective wards.

Section 10. The Clerk of said City of Payette is hereby authorized and directed to secure the printing of and have printed the ballots for said election, and make all other necessary arrangements for the holding of said election.

SECTION 11. This Ordinance shall be in full force and effect from and after its passage and approval and the publication thereof as provided by law.
