

ORDINANCE NO. 692

AN ORDINANCE PROVIDING THAT CERTAIN PROPERTY SHALL BE EXCLUDED FROM THE BOUNDARIES OF THE CITY OF PAYETTE AND CORRECTING THE DESCRIPTION SET FORTH IN ORDINANCE NO. 687.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF PAYETTE:

Section 1. That on the 3rd of January, 1966 the Council passed and the Mayor approved Ordinance No. 687 of the City of Payette excluding certain property from the boundaries of the City of Payette; that the description therein set forth was erroneous; that said Ordinance was filed for record and recorded in Book 18 Miscellaneous at page 903, County Records of Payette County, Idaho; that it is now the intention of the Council and the Mayor of the City of Payette by the passage of this Ordinance to correct the error in the description therein set forth.

Section 2. That the following described property, to-wit:
Beginning at the Northeast corner of Block 9 of the Hughes Subdivision as filed for record in the office of Payette County Recorder; Thence West along the North side line of said Block 9 to the Northwest corner thereof; thence west 50 feet to the East side line of Block 2 of said Hughes Subdivision; thence South along said East side line to the Northeast corner of Lot 13 in said Block 2; thence West along the North side line of said Lot 13 a distance of 196.70 feet to the Northwest corner thereof, said point being also on the East side line of Ireton's First Subdivision as filed for record in the office of the Payette County Recorder; thence South along said East side line to the Southeast corner of Block 9 in said Ireton's First Subdivision; thence West along the South side line of said Block 9 a distance of 537.86 feet to the Southwest corner thereof; thence West to the Easterly side line of the Union Pacific Railroad Company right-of-way; thence in a North-easterly direction along said right-of-way to the intersection of said right-of-way line with the extension of the North side line of Block 14 of said Hughes Subdivision; thence East along said extended North side line of said Block 14 to the Northwest corner of said Block 14; thence East along said North side line of said Block 14 to the Northeast corner thereof; thence South along the East side line of said Hughes Subdivision to the Northeast corner of Block 9 thereof, being the point of beginning;

be and the same is hereby excluded from the boundaries of said City, and in all plats and maps of the said City the same shall not appear as a part of the boundaries thereof.

Section 3. This Ordinance shall be in force and effect from and after its passage, approval and publication.
