

ORDINANCE 717

AN ORDINANCE MAKING AN AMENDED ANNUAL APPROPRIATION AND LEVY FOR GENERAL, STREET LIGHTING, LIBRARY, FIRE DEPARTMENT, RECREATION, L.I.D. GUARANTEE FUND, BOND INTEREST, BOND SINKING, SEWER AND STORM SEWER MAINTENANCE, AIRPORT, STREET, SPRINKLING, FLUSHING AND OILING

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF PAYETTE, IDAHO

SECTION 1. That the sum of \$224,201.88 together with fines, forfeitures and other money not otherwise appropriated, is hereby appropriated for the General Expenses of the City of Payette, Idaho for the fiscal year commencing January 1, 1967.

SECTION 2. That the sum of \$6,719.00 is hereby appropriated for the purpose of lighting the streets and avenues and thoroughfares of the City of Payette, Idaho and the same shall constitute the Street Lighting Fund.

SECTION 3. That there is hereby appropriated for the fiscal year commencing with the first day of January 1967 the sum of \$14,410.00 for the purpose of maintaining a Public Library and the same shall constitute the Library Fund.

SECTION 4. The sum of \$20,201.99 is hereby appropriated for the Fire Department Fund commencing with the first day of January 1967 for the purpose of maintaining the Fire Department and the same shall constitute the Fire Department Fund.

SECTION 5. That there is hereby appropriated for the fiscal year commencing with the first day of January 1967 the sum of \$7,200.28 for the purpose of maintaining the Recreation program and the same shall constitute the Recreation Fund.

SECTION 6. That there is hereby appropriated for the fiscal year commencing with the first day of January 1967 the sum of \$15,395.63 for the purpose of maintaining a L.I.D. Guarantee Fund for the City of Payette and the same shall constitute the Local Improvement District Fund.

SECTION 7. That there is hereby appropriated for the fiscal year commencing with the first day of January 1967 the sum of \$2,107.78 for the purpose of paying the interest on all outstanding General Obligation bonds of the City of Payette, Idaho and the same shall constitute the Bond Interest Fund.

SECTION 8. That there is hereby appropriated for the fiscal year commencing with the first day of January 1967 the sum of \$12,985.47 for the purpose of the redemption of the outstanding General Obligation Bonds of the City of Payette, Idaho and the same shall constitute the Bond Sinking Fund.

SECTION 9. That there is hereby appropriated for the fiscal year commencing with the first day of January 1967 the sum of \$9,564.45 for the purpose of maintaining the Sewer Maintenance and Storm Sewers of the City of Payette and the same shall constitute the Storm Sewer Maintenance Fund.

SECTION 10. That there is hereby appropriated for the fiscal year commencing with the first day of January 1967 the sum of \$2,344.95 for the purpose of maintaining an Airport for the City of Payette and the same shall constitute the Airport Fund.

SECTION 11. That there is hereby appropriated for the fiscal year commencing with the first day of January 1967 the sum of \$8,257.34 for the purpose of Street Sprinkling, Flushing and Oiling Fund.

SECTION 12. That there is hereby levied for the fiscal year commencing with the first day of January 1967 the sum of Twenty-Six Mills (26) mills on each one dollar of the assessed valuation of all the taxable property within the corporate limits of the City of Payette, Idaho and the funds realized from such levy together with all fines, licenses, forfeitures and money not otherwise appropriated shall be for and constitute the General Fund of the City of Payette, Idaho.

SECTION 13. That there is hereby levied for the fiscal year commencing with the first day of January 1967 the sum of Five and two-tenths mills (5.2) mills on each one dollar of the assessed valuation of all the taxable property within the corporate limits of the City of Payette, Idaho, and the funds realized from such levy shall be and the same shall constitute the Street Lighting Fund.

SECTION 14. That there is hereby levied for the fiscal year commencing with the first day of January 1967 the sum of Five (5.0) mills on each one dollar of the assessed valuation of all the taxable property within the corporate limits of the City of Payette, Idaho and the funds realized from such levy shall be and the same shall constitute the Library Fund.

SECTION 15. That there is hereby levied for the fiscal year commencing with the first day of January 1967 the sum of Six (6.0) mills on each one dollar of the assessed valuation of all of the taxable property within the corporate limits of the City of Payette, Idaho and the funds realiz-ed from such levy shall be and the same shall constitute the Fire Department Fund.

SECTION 16. That there is hereby levied for the fiscal year commencing with the first day of January 1967 the sum of Three (3.0) mills on each one dollar of the assessed valuation of all of the taxable property within the corporate limits of the City of Payette, Idaho and the funds realized from such levy shall be and the same shall constitute the Recreation Fund.

SECTION 17. That there is hereby levied for the fiscal year commencing with the first day of January 1967 the sum of One (1.0) mill on each one dollar of the assessed valuation of all the taxable property within the corporate limits of the City of Payette, Idaho and the funds realized from such levy shall be and the same shall constitute the Local Improvement District Fund.

SECTION 18. That there is hereby levied for the fiscal year commencing with the first day of January 1967 the sum of Four Tenths (0.4) mills on each one dollar of the assessed valuation of all the taxable property within the corporate limits of the City of Payette, Idaho and the funds realized from such levy shall be and the same shall constitute the Bond Interest Fund.

SECTION 19. That there is hereby levied for the fiscal year commencing with the first day of January 1967 the sum of Four Tenths (0.4) mills on each one dollar of the assessed valuation of all of the taxable property within the corporate limits of the City of Payette, Idaho and the funds realized from such levy shall be and the same shall constitute the Bond Sinking Fund.

SECTION 20. That there is hereby levied for the fiscal year commencing with the first day of January 1967 the sum of Two (2.0) mills on each one dollar of the assessed valuation of all the taxable property within the corporate limits of the City of Payette, Idaho and the funds realized from such levy shall be and the same shall constitute the Storm Sewer Maintenance Fund.

SECTION 21. That there is hereby levied for the fiscal year commencing with the first day of January 1967 the sum of One (1.0) mill on each one dollar of the assessed valuation of all the taxable property within the corporate limits of the City of Payette, Idaho and the funds realized from such levy shall be and the same shall constitute the Airport Fund.

SECTION 22. That there is hereby levied for the fiscal year commencing with the first day of January 1967 the sum of Two (2.0) mills on each one dollar of the assessed valuation of all the taxable property within the corporate limits of the City of Payette, Idaho and the funds realized from such levy shall be and the same shall constitute the Street Oil, Sprinkle and Flush Fund.
