ORDINANCE NO. 770

BY COUNCILMAN NEIL BASKETT

AN ORDINANCE GIVING NOTICE TO ALL CITIZENS OF, AND OWNERS OF PROPERTY IN THE CITY OF PAYETTE, IDAHO, THAT AN APPLICATION HAS BEEN PRESENTED FOR THE VACATION OF A PORTION OF FIRST AVENUE SOUTH WITHIN THE CITY OF PAYETTE, PAYETTE COUNTY, IDAHO.

BE IT ORDAINED AND ESTABLISHED By the Mayor and the Council of the City of Payette, Idaho:

Section 1. That an application has been presented to the Mayor and the Council of the City of Payette, Idaho, for the passage and approval of an ordinance vacating a portion of First Avenue South within the City of Payette, Payette County, Idaho, the said portion to be vacated is described as follows, to wit:

In the City and County of Payette, Idaho, situate in the NE1/4 SE1/4 of Section 33, Township 9 North, Range 5 West, Boise Meridian;

In W. F. Masters Plat of the City of Payette as per Plat records in the office of the Payette County Recorder of Payette, Idaho in Book 1 at Page 20 of Plats:

Beginning at the Southeast corner of Lot 10 of Block 3 for a TRUE POINT OF BEGINNING; thence South a distance of 100 feet to the Northeast corner of Lot 1 of Block 2; thence West along the North sideline of Lot 1 of Block 2 a distance of 145 feet to the Northwest corner of Lot 1 of Block 2; thence North a distance of 100 feet to the Southwest corner of Lot 10 of Block 3; thence East along the South sideline of Lot 10 of Block 3 a distance of 145 feet to the Southeast corner of Lot 10 of Block 3, the TRUE POINT OF BEGINNING.

Section 2. That said application will be considered under a suspension of the requirements that an ordinance be read on three different days at a meeting of the Council of the City of Payette, Idaho, to be held on the 3rd day of ~~December~~ ^{JANUARY}, 1972, at the hour of 8:00 o'clock p.m., Mountain Standard Time, at the Council Chambers in the City Hall in the City of Payette,

when and where, or prior to which date any citizen of the City of Payette or any owner of property in the City of Payette may file with the Clerk of the City of Payette any claim for damages which any such citizen or owner of property may sustain by reason of the vacation of the said property and all claims for damages so filed will be considered and ascertained by the Council of the City of Payette, at said meeting.

Section 3. Notice of the foregoing will be given to all citizens of, and owners of property in the City of Payette, Idaho, by publication of this ordinance in the Independent Enterprise, a newspaper published in the City of Payette, Idaho, in one issue thereof published on the 23rd day of December, 1971.
