

ORDINANCE NO. 870

AN ORDINANCE REPEALING THE FOLLOWING SECTIONS AND CHAPTERS OF THE MUNICIPAL CODE OF THE CITY OF PAYETTE, IDAHO: CHAPTER 1 OF TITLE 1 WHICH CONTAINS PROVISIONS FOR THE ADOPTION AND ACCEPTANCE OF A MUNICIPAL CODE, AND WHICH ALSO PROVIDES FOR AMENDMENTS TO SAID CODE, THE CONSTRUCTION DEFINITIONS, AND INTERPRETATIONS OF WORDS, AND ALSO PROVISIONS FOR PENALTIES IN THE EVENT OF A VIOLATION OF THE CODE, AND PROVISIONS FOR LIABILITY OF OFFICERS: CHAPTER 2 OF TITLE 1 WHICH PROVIDES FOR REPEALER OF GENERAL ORDINANCES, EXCEPTION TO REPEALER OF ORDINANCES, AND A SAVINGS CLAUSE: CHAPTER 3 OF TITLE 1 WHICH PROVIDES FOR SPECIFIC PENALTIES FOR VIOLATION OF THE MUNICIPAL CODE, PROVIDES FOR PENALTIES FOR DRIVING WHILE INTOXICATED, PROVIDES FOR REVOCATION OF LICENSES IN THE EVENT OF CONVICTION OF A VIOLATION OF THE CODE AND PROVIDES FOR THE WORKING OF PRISONERS; SECTION 1-4-13 PROVIDING FOR A PENALTY FOR A VIOLATION OF THE CODE; CHAPTER 8 OF TITLE 1 PROVIDING FOR A DEPOSITORY; CHAPTER 20 OF TITLE 1 PROVIDING FOR THE DUTIES OF HAND-MASTER; SECTION 7 OF CHAPTER 3 OF TITLE 2 WHICH PROVIDES FOR REPEALING OF CONFLICTING ORDINANCES; SECTION 15 OF CHAPTER 3 OF TITLE 8 PROVIDING FOR A SAVINGS CLAUSE; SECTION 12 OF CHAPTER 1 OF TITLE 6 PROHIBITING LOITERING; SECTION 3 OF CHAPTER 2 OF TITLE 7 PROVIDING FOR REPEAL OF CONFLICTING ORDINANCES; SECTION 8 OF CHAPTER 4 OF TITLE 4 PROVIDING FOR A SAVINGS CLAUSE; CHAPTER 5 OF TITLE 4 PROVIDING FOR THE REGULATION OF THE HEIGHT OF AWNINGS; SECTION 12 OF CHAPTER 15 OF TITLE 11 PROVIDING FOR A SAVINGS CLAUSE; CHAPTER 1 OF TITLE 10, SECTION 7 OF CHAPTER 2 OF TITLE 10, SECTIONS 3, 4, 5, 6, 7, 8 AND 9 OF CHAPTER 3 OF TITLE 10, CHAPTER 5 OF TITLE 10, CHAPTER 6 OF TITLE 10, SECTIONS 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, AND 12 OF CHAPTER 7 OF TITLE 10, CHAPTER 9 OF TITLE 10, SECTIONS 1, 2, 3, 4, 5, 10, 11, 12, AND 13 OF CHAPTER 10 OF TITLE 10, CHAPTERS 11, 12, 13, 14, 15 AND 16 OF TITLE 10, SECTIONS 1, 2, 3, 4, 5, 6, 7, 8 AND 9 OF CHAPTER 17 OF TITLE 10, ALL OF WHICH PROVIDE FOR REGULATION OF TRAFFIC WITHIN THE CITY; CHAPTER 1 OF TITLE 5 PROVIDING FOR THE LICENSING OF VARIOUS ACTIVITIES WITHIN THE CITY OF PAYETTE, IDAHO, AND CHAPTER 7 OF TITLE 4 WHICH PROVIDES FOR THE REGULATION OF GAS FACILITIES AND PIPING.

Be it ordained by the Mayor and Council of the City of Payette, Idaho, that the following Ordinances are hereby repealed:

Chapter 1 of Title 1 which contains provisions for the adoption and acceptance of a municipal code and which also provides for amendments to said code, the construction definitions, and interpretations of words, and also provisions for penalties in the event of a violation of the Code, and provisions for liability of officers;

Chapter 2 of Title 1 which provides for repealer of general ordinances, exception to repealer of ordinances and a savings clause;

Chapter 3 of Title 1 which provides for specific penalties for violation of the municipal code, provides for penalties for driving while intoxicated, provides for revocation of licenses in the event of conviction of a violation of the Code and provides for the working of prisoners;

Section 1-4-13 providing for a penalty for a violation of the code;

Chapter 8 of Title 1 providing for a depository;

Chapter 20 of Title 1 providing for the duties of a bond master;

Section 7 of Chapter 3 of Title 2 which provides for repealing of conflicting ordinances;

Section 15 of Chapter 3 of Title 8 providing for a savings clause.

Section 12 of Chapter 1 of Title 6 prohibiting loitering;

Section 3 of Chapter 2 of Title 7 providing for Repeal of Conflicting Ordinances;

Section 8 of Chapter 4 of Title 4 providing for a savings clause;


Chapter 5 of Title 4 providing for the regulation of the height of awnings;

Section 12 of Chapter 15 of Title 11 providing for a savings clause;


Chapter 1 of Title 10; Section 7 of Chapter 2 of Title 10; Sections 3, 4, 5, 6, 7, 8, and 9 of Chapter 3 of Title 10; Chapter 5 of Title 10; Chapter 6 of Title 10; Sections 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11 and 12 of Chapter 7 of Title 10; Chapter 9 of Title 10; Sections 1, 2, 3, 4, 5, 10, 11, 12, and 13 of Chapter 10 of Title 10; Chapters 11, 12, 13, 14, 15 and 16 of Title 10; Sections 1, 2, 3, 4, 5, 6, 7, 8 and 9 of Chapter 17 of Title 10, all of which provide for regulation of traffic within the City;

Chapter 1 of Title 5 providing for the licensing of various activities within the city of Payette, Idaho, and Chapter 7 of Title 4 which provides for the regulation of gas facilities and piping.
