

ORDINANCE NO 968

AN ORDINANCE OF THE CITY OF PAYETTE, IDAHO, DELETING SECTION 6.08.050 OF THE PAYETTE MUNICIPAL CODE; AMENDING SECTION 6.08.060 WITH THE ADDITION OF CERTAIN LANGUAGE; RENAMING SECTION B; ADDING A NEW SECTION B; ESTABLISHING AN EFFECTIVE DATE; REPEALER; SEVERABILITY.

BE IT ORDAINED AND RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF PAYETTE, IDAHO:

SECTION 1: That Section 6.08.050 of the Payette Municipal Code is hereby rescinded, amended and deleted from the Payette Municipal Code.

SECTION 2: That Subsection B of Section 6.08.060 of the Payette Municipal Code is hereby renamed Section C.

SECTION 3: That Section 6.08.060 of the Payette Municipal Code is amended with the addition of a new Section B, which shall read as follows:

"Any owner, possessor or person who keeps any dog shall construct and maintain an enclosure or a retaining system sufficient to restrain any dog kept or maintained on the premises at all times within the limits as set forth by Subsection A above. This enclosure shall be sufficient to keep other persons from entering and releasing an otherwise adequately restrained dog."

SECTION 4: That Subsection C, formerly Subsection B, of Section 6.08.060 of the Payette Municipal Code is hereby amended by the insertion of the following language:

"Any owner, possessor or person who keeps any dog violating the provisions of this section, or fails to construct or maintain an enclosure or a restraining system sufficient to restrain a dog at all times or sufficient to keep others from releasing your dogs, shall, upon conviction thereof, be punished by a fine of not more than \$25.00 for the first occurrence, \$50.00 for the second occurrence and \$100.00 for each occurrence thereafter."


SECTION 5: Any portions of any existing Ordinances which are in direct conflict with this Ordinance are hereby repealed

insofar as the conflict exists.


SECTION 6: If any portion of this Ordinance is found to be unenforceable or unconstitutional for any reason, the remaining portion of this Ordinance shall remain in full force and effect.

BE IT ORDAINED AND RESOLVED THAT THIS ORDINANCE SHALL BE IN FULL FORCE AND EFFECT FROM AND AFTER ITS APPROVAL, PASSAGE AND PUBLICATION AS REQUIRED BY LAW.

This Ordinance shall be in full force and effect on the 15th day of September, 1986.
