

ORDINANCE NO. 180 BY Brainard

AN ORDINANCE EXTENDING THE CORPORATE LIMITS ~~OF THE CITY~~ OF THE CITY OF PAYETTE, IDAHO, BY DECLARING CERTAIN TERRITORY CONTIGUOUS AND ADJACENT THERETO A PART OF THE SAID CITY.

Be it ordained by the Mayor and Council of the City of Payette:

Section 1. That the corporate limits of the City of Payette, Idaho, be and the same are hereby extended by including the following described territory ^{within the corporate limits} ~~apart~~ of the said City of Payette, to wit:

Beginning at the North-east corner of Block 11 of Riverside Addition to Payette, as the same appears from the official plat filed for record in the office of the Recorder of Canyon County, Idaho, thence West 1023 feet; thence South 1320 feet; thence East 33 feet; thence South 123 feet; thence East 132 feet; thence South 220 feet; thence East 198 feet to an intersection with the present City limits; thence North 1363 feet; thence East 660 feet; thence North 297.99 feet to the place of beginning;

Also beginning at the Northeast corner of Block 59 of Riverside Addition to Payette, Idaho, as the same appears from the official plat of said Addition now on file and of record in the office of the Recorder of Canyon County, Idaho, thence West 660 feet; thence South 1312 feet; thence West ~~530~~⁵²⁰ 660 feet; thence South 350 feet ~~thence~~ to the present City Limits; thence East 1320 feet; thence North 671 feet; thence East 660 feet; thence North 330 feet; thence West 660 feet; thence North 660 feet to the place of beginning;

Also beginning at a point on the South line of Section 34, Township 9 North, Range 5 West of the Boise Meridian, in Canyon County, Idaho, 3250 feet East of the East end of the County Bridge across the Payette River, thence East 940 feet to an intersection with the West line of the Lower Payette Ditch; thence following said line in a Northerly direction to an intersection with the

South line of Payette Avenue; thence West 1100 feet; thence South 1339 feet to the place of beginning;

Also beginning at a point 1585 feet East of the Southwest corner of Block 16 of Gorrie's Addition to the City of Payette, Idaho, as the same appears from the official plat thereof, filed for record in the office of the Recorder of Canyon County, Idaho, thence North ~~500~~⁴⁰⁰ feet; thence East ~~615~~⁶⁹⁰ feet; thence South ~~500~~⁴⁰⁰ feet; thence West ~~615~~⁶⁹⁰ feet to the place of beginning.

Section 2. After the passage, approval and publication of this ordinance, the said pieces and parts of land herein described shall be and become a part of the City of Payette, Idaho.
