AN ORDINANCE PROVIDING FOR THE RENAMING OF THE STREETS AND AVENUES OF THE CITY OF PAYETTE, IDAHO.

Be it ordained by the Mayor and Council of the City of Payett:

Section 1. That all streets and avenues running in an ~~East~~ and ~~West~~ direction and all streets and avenues that shall hereafter be opened up or laid out in any addition to the City of Payette, Idaho, shall be known and designated as avenues; and all streets and avenues running in a North and South direction and all streets and avenues that shall hereafter be opened up or laid out running in said directions, shall be known and designated as streets.

Section 2. Beginning at the extreme Western part of the City along the Payette river, the different streets and avenues shall be named as follows: Gorrie Lane shall be River Street; ~~the North and South street~~ ^{running} through the center of Peters' Second Addition, shall be Second Street; Lynn street shall be Fourth Street; Indiana Street shall be Fifth Street; Front Street and Riverside Avenue shall be Sixth street; Broad Street shall be Seventh Street; Boise Street shall be Eighth Street; Park Street shall be Ninth Street; Pence Street shall be Tenth Street; Gorrie Street shall be Eleventh street; King Street ^{and now} shall be Twelfth Street; Fulton Street shall be Thirteenth Street; Bates Street shall be Fourteenth Street; Pinkham Street shall be Fifteenth Street; Gipson Street shall be Sixteenth Street; County road on North of Lower Payette Ditch shall be Eighteenth Street; High Street shall be Nineteenth Street; and Brown Street shall be Twentieth Street.

Also beginning near the ^{the} central part of the business district of the City, ~~Main Street~~ the streets, and avenues shall be named as follows: Main Street shall be Center Avenue; Commercial Street shall be ^{First} ~~Second~~ Avenue North; Mill street shall be ^{Second} ~~Third~~ Avenue.

Avenue North; Tioga Street shall be Third Avenue North; Morrison and Wilhelm Streets shall be Fourth Avenue North; Ash Street shall be Fifth Avenue North; Alta Street shall be Sixth Avenue North; College Street shall be Seventh Avenue North; Un-named Street on the North of Hinze Addition Eighth Avenue North; Ada Avenue shall be First Avenue South; Grand Avenue shall be Second Avenue South; Payette Avenue shall be Third Avenue South; County Road on South of Fairview Addition shall be Sixth Avenue South and Tennessee Street shall be Railroad Street. *Lawe.*
