

ORDINANCE NO. 370 by McCarroll

AN ORDINANCE MAKING AN ANNUAL APPROPRIATION AND LEVY FOR GENERAL ROAD, SALARY, MUNICIPAL BAND, STREET LIGHTING AND LIBRARY PURPOSES, AND THE PAYMENT OF INTEREST ON THE OUTSTANDING BONDED INDEBTNESS, AND THE REDEMPTION OF OUTSTANDING WARRANTS AND BONDED INDEBTNESS OF THE CITY OF PAYETTE, IDAHO.

Be it ordained by the Mayor and council of the City of Payette, Idaho:

Section 1: That the sum of \$14,780.00, together with all fines, forfeitures, and other money not otherwise appropriated, is hereby appropriated for the general expenses of the city of Payette, Idaho, for the fiscal year commencing on the first Tuesday of May, A. D. 1926.

Section 2: That the sum of \$1200.00 is hereby appropriated for the fiscal year commencing with the first Tuesday of May, A. D. 1926, for the purpose of maintaining a Municipal Band in the City of Payette, Idaho.

Section 3:

Section 3: That the sum of \$6000.00, is hereby appropriated for the fiscal year commencing with the first Tuesday of May, A. D. 1926, for the purpose of lighting the streets and thoroughfares of the City of Payette, Idaho.

Section 4: That the sum of \$8500.00, is hereby appropriated for the fiscal year commencing with the first Tuesday of May, A. D. 1926, for the purpose of paying interest on all General Bonds issued by the City of Payette, Idaho, and the same shall constitute the Bond Interest Fund of said City.

Section 5: That the sum of \$2000.00, is hereby appropriated for the fiscal year commencing on the first Tuesday of May, A. D. 1926, for the purpose of the redemption of the outstanding warrant indebtedness of said City of Payette, Idaho, and the same shall constitute the Warrant Redemption Fund of said City.

Section 6: That the sum of \$2600.00, is hereby appropriated for the fiscal year commencing on the first Tuesday of May, A. D. 1926, for the purpose of the redemption of the outstanding general bonds of the City of Payette, Idaho, and the same shall constitute the Bond Sinking Fund of the said City.

Section 7: That the sum of \$600.00, is hereby appropriated for the fiscal year commencing on the first Tuesday of May, A. D. 1926, for the purpose of maintaining a public library in the City of Payette, Idaho, and the same shall constitute the Library Fund of said City.

Section 8: That there is hereby levied, for the fiscal year commencing on the first Tuesday of May, A. D. 1926, against all the taxable property within the corporate limits of the City of Payette, Idaho, the sum of Ten (10) mills, on each one dollar of the assessed valuation of said property, and the funds realized from such levy, together with all licenses, fines, forfeitures, and moneys not otherwise appropriated, shall be for and constitute the general fund of the said City of Payette, Idaho.

Section 9: That there is hereby levied, for the fiscal year commencing on the first Tuesday of May, A.D. 1926, against all the taxable property within the corporate limits of the City of Payette, Idaho, the sum of one-half ( $\frac{1}{2}$ ) of one (1) mill, on each one dollar of the assessed valuation of said property, and the funds realized from such levy shall be and constitute the Library Fund of the said City of Payette, Idaho.

Section 10: That there is hereby levied, for the fiscal year commencing on the first Tuesday of May, A.D. 1926, against all the taxable property within the corporate limits of the City of Payette, Idaho, the three (3) millson each one dollar of the assessed valuation of said property, and the funds realized from such levy, shall be and constitute the Street Lighting Fund of said City of Payette, Idaho.

Section 11: That there is hereby levied, for the fiscal year commencing on the first Tuesday of May, A.D. 1926, against all the taxable property within the corporate limits of the City of Payette, Idaho, the sum of two and three-fourths ( $2\frac{3}{4}$ ) mills on each one dollar of the assessed valuation of said property, and the funds realized from such levy shall be, and constitute, the Warrant Redemption Fund of said City of Payette, Idaho.

Section 12: That there is hereby levied, for the fiscal year commencing on the first Tuesday of May, A. D. 1926, against all the taxable property within the corporate limits of the City of Payette, Idaho, the sum of eight and one-fourth ( $8\frac{1}{4}$ ) mills on each one dollar of the assessed valuation of said property, and the funds realized from such levy shall be, and constitute, the Bond Interest Fund of the said City of Payette, Idaho.

Section 13: That there is hereby levied, for the fiscal year commencing on the first Tuesday of May, A. D. 1926, against all the taxable property within the corporate limits of the City of Payette, Idaho, the sum of two and one-half ( $2\frac{1}{2}$ ) mills on each one dollar of the assessed valuation of said property, and the funds realized from such levy shall be, and constitute, the Bond Sinking Fund of said City of Payette, Idaho.

Section 14: That there is hereby levied for the fiscal year commencing on the first Tuesday of May, A.D. 1926, against all the taxable property within the corporate limits of the City of Payette, Idaho, the sum of one (1) mill on each one dollar of the assessed valuation of said property, and the funds realized from such levy shall be, and constitute, the Municipal Band Fund of said City of Payette, Idaho.
