Payette Municipal Code Sections 16.04

16.26.010 Purpose: The purpose of the short plat is to allow the creation of up to three (3) parcels without being subject to the procedural provisions of the preliminary and final plat regulations of this title and to provide a simplified administrative procedure for processing the division of three (3) or less divisions of land. A record of survey, application and fee, set by resolution of the city council, shall be required. Every division of land for the purpose of sale, lease or transfer into three (3) or fewer lots, tracts or parcels within the city, where no new public dedications are required, may proceed in compliance with this section.

Notice to Applicants

- Before an application is submitted, a conference with current Planning staff is recommended.
- There will be no refund of any application fee for approvals not granted or withdrawn.
- No incomplete applications will be acted upon.
- The applicant is advised to include all attachments required as a part of the application.
- The applicant should provide this application to his Surveyor to ensure all items are included on the submitted survey.
- No Short Plat will be acted on if the property has been subdivided within the last 5 years
- The verbiage below must appear on the plat for the engineer to sign:
